25 This matter came on a hearing on the *ex parte* application of Plaintiffs JIN HONG KIM;  
26 YON SUNG KOO; and SOO EAON SHIN (collectively, "Plaintiffs") for the following order:  
27 (1) for a Temporary Restraining Order and an Order to Show Cause re Preliminary Injunction to  
28 enjoin and refrain Defendant David Kwon aka Nam Hyuk Kwon from entering onto the Irvine

1 Baptist Church (“IBC”)’s property located at 5101 Walnut Avenue, Irvine, California 92604  
2 without Plaintiffs’ prior consent in writing; (2) for a Temporary Restraining Order and an Order  
3 to Show Cause re Preliminary Injunction to enjoin and refrain Defendants David Kwon aka  
4 Nam Hyuk Kwon, Boksup Lee, Harris Kwon aka Hyuk Jung Kwon, Eric Songho Lee, Ilkwon  
5 Lee and Young Jo Shin from interfering with Plaintiffs’ ability as directors of the Board of IBC  
6 to manage and control the IBC’s real and personal property and activities, including worship  
7 service, bank accounts, monies, and rent collections from Dreamland Preschool; (3) for a  
8 Temporary Restraining Order and an Order to Show Cause re Preliminary Injunction to enjoin  
9 and refrain Defendants David Kwon aka Nam Hyuk Kwon, Boksup Lee, Harris Kwon aka Hyuk  
10 Jung Kwon, Eric Songho Lee, Ilkwon Lee and Young Jo Shin from holding and/or conducting  
11 any meetings not authorized by Plaintiffs as directors of the Board of IBC; and (4) for  
12 Defendants David Kwon aka Nam Hyuk Kwon, Boksup Lee, Harris Kwon aka Hyuk Jung  
13 Kwon, Eric Songho Lee, Ilkwon Lee and Young Jo Shin to turn over and deliver all books,  
14 records, keys, computers, corporate and financial information in writing, and any other property  
15 of IBC to Plaintiffs, no later than Saturday, August 17, 2019, 12 noon at the IBC’s offices.

16 This court, having read and considered this Application, the Opposition, the declarations  
17 for the respective parties, and oral argument in court, hereby orders as follows:

- 18 1. Plaintiffs’ Request for Order No. 1 above is GRANTED.
- 19 2. Plaintiffs’ Request for Order No. 2 above is GRANTED.
- 20 3. Plaintiffs’ Request for Order No. 3 above is GRANTED.
- 21 4. Plaintiffs’ Request for Order No. 4 above is GRANTED

26 Based upon the complaint filed in this action, the Application and the declarations in  
27 support thereof, YOU ARE HEREBY ORDERED TO APPEAR on \_\_\_\_\_, 2019 at 1:30  
28 p.m. in Department C32 of the Superior Court of the State of California for the County of

1 Orange, Central Justice Center, located at 700 Civic Center Drive West, Irvine, California  
2 92701, to show cause why a preliminary injunction should not issue, pending entry of judgment  
3 pursuant to Corporations Code section 9418, to enjoin and refrain (1) *Defendant David Kwon*  
4 *aka Nam Hyuk Kwon* from entering onto the IBC's property located at 5101 Walnut Avenue,  
5 Irvine, California 92604 without Plaintiffs' prior consent in writing; (2) *Defendants David Kwon*  
6 *aka Nam Hyuk Kwon, Boksup Lee, Harris Kwon aka Hyuk Jung Kwon, Eric Songho Lee, Ilkwon*  
7 *Lee and Young Jo Shin* from interfering with Plaintiffs' ability as directors of the Board of IBC  
8 to manage and control the IBC's real and personal property and activities, including worship  
9 service, bank accounts, monies, and rent collections from Dreamland Preschool; and (3)  
10 *Defendants David Kwon aka Nam Hyuk Kwon, Boksup Lee, Harris Kwon aka Hyuk Jung Kwon,*  
11 *Eric Songho Lee, Ilkwon Lee and Young Jo Shin* from holding and/or conducting any meetings  
12 not authorized by Plaintiffs as directors of the Board of IBC.

21 **TEMPORARY RESTRAINING ORDER**

22 Pending hearing on the order to show cause, Defendants DAVID KWON aka NAM  
23 HYUK KWON; BOKSUP LEE; HARRIS KWON aka HYUK JUNG KWON; ERIC SONGHO  
24 LEE; ILKWON LEE; and YOUNG JO SHIN (collectively, "Defendants") are hereby enjoined  
25 and refrained from (i) representing themselves as directors, officers, representatives and/or  
26 agents of IBC, (ii) acting as directors, officers, representatives and/or agents of IBC, and (iii)  
27 interfering with Plaintiffs' ability as directors and/or officers of IBC in managing the activities  
28 and affairs of IBC, pursuant to IBC's constitution and California Corporations Code.
